Proposed amendments to GPVA Bylaws

Amendment 1: Amend GPVA Bylaws, 14. Officers, 14.2 Duties, Section 14.2.1.5 which reads:

"14.2.1.5 Record the minutes of GPVA business meetings and distribute at least one copy to each local within two weeks of the meeting."

to read:

"14.2.1.5 Record the minutes of GPVA meetings and present at the subsequent meeting for approval. No minutes shall be posted on the GPVA website for general public access nor shared electronically with non-active members."

Amendment 2: Amend GPVA Bylaws, 7. Membership, 7.1 Eligibility to add a new section 7.1.4 as follows:

"7.1.4 Active membership shall be renewed annually beginning January 1 of each year, with the payment of annual dues. The dues are: \$25 per year; and for students, senior citizens and low income individuals: \$10. In case of economic hardship the Treasurer is authorized to waive dues upon receipt of a request from a member to do so. Members must be current on their dues to actively participate and vote on matters before the party."
