The interim appointments of Stephanie Aubuchon to the Animal Rights Committee, of Blaizen Bloom as an alternate National Delegate, and of Davion Washington to the Diversity Committee were approved by consensus.

NEW BUSINESS:

OFFICER ELECTIONS:

(28:00) Tom Yager was elected as non-female Co-Chair for a term of two years.

(35:00) The Press Secretary position had no candidate, and is left vacant.

(37:00) Sid Smith was reelected as General Secretary for a term of two years with Blue Ridge Greens standing aside.

(50:00) Charlie Jordan was elected as List-serve Moderator for a term of 1 year.

(58:00) Blue Ridge National Platform Amendment Proposals. It was agreed to defer most of the proposed amendments to the interim committee for voting by OpaVote. The housekeeping proposals were deferred to the GPUS Platform Committee by consensus. The proposal to change the word "defense" to the word "military" in those proposals was accepted by consensus. The proposal to change the word American to Usonian was defeated on a voice vote.

WRITTEN REPORTS:

Co-chairs (Blaizen Bloom):

Fellow Greens,

Since the last meeting, a few interim decisions have been made that will require affirmation at our January 29th meeting. The first is the appointment and election of 3 representatives to various National Committees including Blaizen Bloom to the National Committee as an Alternate Delegate, Steffanie Aubuchon to the Animal Rights committee, and Davion Washington to the Diversity Committee. Additionally, the GPVA chose to co-sponsor two webinars by the St. Louis Green's: the November 3rd "Agriculture as a Weapon of Domination" and December 1st "Healing a Broken Agricultural System" webinars.

Outside of that, we are looking forward to our upcoming meeting which will include discussions and votes on a wide variety of topics. Two of the longest discussed plans being the reworked Candidate Questionnaire and tweaked Strategic Plan for 2022. In addition, we look forward to the revised Social Media policy brought forward by Press-Secretary Davion Washington which will update our current policy to include Instagram and YouTube. Finally, we're looking forward to hearing from prospective candidates including two who will be seeking the nomination of our Party.

However, moving forward we hope to grow the Party further and expand upon past successes by our Locals. To accomplish this, we're hoping to work within the frames of the Strategic Plan if passed and in conjunction with our currently established Locals. This includes developing a more engaging member onboarding process, leading phone and text banks to reach out to prospective Greens, and working with starting and grounded Locals to develop individualized plans for growth. In addition, we're looking to develop a process to onboard interested candidates and connect them with their Locals and available resources within the Party including by the national Coordinated Campaign Committee.

LOCALS

Arlington (John Reeder):

Arlington Greens met online on Jan. 12, 2021 with three members participating. Our delegate to GPVA is myself, John Reeder, Our treasurer is Steve Davis.

Major topics at our meeting were: the county carbon emissions reduction (CEP) program, historic preservation efforts, and the effect of redistricting of state delegate and senate boundaries in Arlington. AGP has been active in CEP for the past 7 years. AGP has supported historic preservation of sites in Arlington with the goal of expanding parkland for the 225,000 residents. Our local state delegate and a NOVA state senator introduced a bill in the 2022 VA General Assembly to improve the state historic preservation law.

Blue Ridge (Charlie Jordan):

As I reported in September, the Blue Ridge Greens met on August 16, 2021. There were three members in attendance.

Fairfax (Jonah Thomas):

Fairfax Green Party will hold elections later this year. Until the elections, our co-chairs are Jonah Thomas and Audrey Clement and our representative is Jonah Thomas.

Our last meeting was January 9 with 7 attendees. We have no new accomplishments to report. We are starting some projects.

Hampton Roads (Stephanie Aubuchon):

Hampton Roads Green Party (HRGP) Local Representative Report for January 29, 2022 GPVA Meeting

Local Rep: Steffanie Aubuchon

Last Meeting: 1-9-22 with 4 HRGP voting members in attendance along with 2 non-voting members (6 total).

Protests:

The HRGP has participated in various protests throughout the Hampton Roads area.

Hampton Roads Greens attended an Anti-War protest on September 11th in Town Center, Virginia Beach.

The HRGP Co-Sponsored a Divest MVP, Wells Fargo protection on October 2nd in Hampton, VA.

The HRGP agreed to broadcast and attend a rally organized by Virginia Beach Municipal Workers seeking recognition of their union (UE 111) and collective bargaining rights on January 18th. Co-Chair Blaizen Bloom spoke at the VA Beach City Council meeting representing the HRGP.

Organizing: Hampton Roads Greens continue to be a part of organizing efforts for local municipal employees gaining collective bargaining rights as well as advocating for COVID-19 protections in local public schools.

Appointments: Since the last State Party meeting, the HRGP has had a few members be appointed to national committees. In an interim vote by the GPVA, HRGP member Blaizen Bloom was appointed to be an alternate National Delegate and Steffanie Aubuchon was appointed to the Animal Rights Committee. In addition, Blaizen Bloom was appointed by the YES Steering Committee to serve on the International Committee.

Candidates: The HRGP currently has two candidates for the 2022 election cycle which have both been nominated and sent to the GPVA for nomination. Those being Blaizen Bloom for Chesapeake School Board and Garry Hubbard for the 2nd Congressional District.

Our members have been active inside the local and elsewhere. Hampton Roads Greens were in attendance at an HR RVA Antiwar Meet and Greet to create a coalition between groups in each area to mobilize against American Imperialism and the Israeli occupation of Palestine on September 12th. Greens were also in attendance at an Anti-War protest on September 11th hosted by the newly formed HR Libertarian Party with the main objective of making contact and creating ties for potential ballot access cooperation.

In addition, HRGP Co-Chair was interviewed on the Long Live Alternative Parties Podcast on December 15th. Furthermore, Hampton Roads Greens have been active in national fundraising efforts to support the current budget for 2022. Finally, Hampton Roads Green Blaizen Bloom was also appointed by YES to represent them to the Global Young Greens Conference on January 14th-16th. Upcoming Events: The HRGP has agreed to amplify another upcoming rally for collective bargaining being hosted by municipal employees up in Newport News on January 25th.

Lynchburg (Davion Washington):

The Lynchburg Local of the GPVA has been heavily engaged in recruitment and membership expansion efforts this past year, revitalizing our current social media pages with plans to create further pages such as Instagram and Twitter, reaching out and engaging with new potential members, and continuing to assess where the local can gain proper footing within the community in the new year. The Lynchburg local has yet to hold a meeting in the new, but our membership expansion efforts continue.

Maintainers, moderators, and other assistants for specific social media accounts may be assigned by the Leadership Council, or by the Press Secretary subject to the consent of the Leadership Council.

Facebook GPVA Main Page: The GPVA Main Facebook Page exists for the promotion of the Green Party of Virginia. The GPVA Main Facebook page will not be a place for party members to debate party positions. The purpose of this page is meant for the Green Party of Virginia to engage with constituents, to promote the party, and to educate non-party constituents about the GPVA, its principles, and its political program. The highest standard of behavior and etiquette is expected from members who participate on the page. Comments and other activity that is counterproductive to the purpose of the GPVA Main Facebook Page may be deleted by the moderators of the page. Moderators will notify the responsible poster in the instance of a deletion, along with the justification for the deletion of the post. Repeat offenders of violations to this policy will be subject to a ban from the page.

Facebook GPVA Organizing and Discussion Page: The GPVA Organizing and Discussion Facebook Page exists as an outlet for GPVA members to engage with each other on topics of direct relevance to the Green Party of Virginia. Only GPVA members may join this page. Greens and others from outside Virginia are not to be given posting privileges. If a post includes a link, image, or any other non-textual elements, the responsible poster must include an accompanying text stating its relevance to the GPVA. Posts about other political parties should never be made unless there is a direct and explicit connection to, comparison to, or contrast with the Green Party. Additionally, all discussion is to observe the highest standards of behavior and etiquette. Constructive criticism and suggestions for improvement of the Green Party are encouraged, but under no circumstances will personal or implied attacks against the Green Party or any member of the Green Party be tolerated. Posts or comments in violation of these guidelines will be deleted by the moderators of the page. Moderators will notify the responsible poster in the instance of a deletion, along with the justification for the deletion of the post. Repeat offenders of violations to this policy will be subject to a ban from the page.

GPVA Twitter & Instagram accounts: The GPVA Twitter and Instagram accounts exist for the promotion of the Green Party of Virginia, the posting of timely information about the GPVA and official GPVA responses and comments to current events. 2022 Green Party of Virginia Strategic Plan

This strategic plan is meant to be adopted yearly by the Leadership Council of the GPVA to provide guidance to the state party. A plan is incredibly important, enabling us to effectively distribute funds, make clear progress, receive actionable feedback, and make wise use of member time and resources.

Every member of the GPVA should know what we are doing, why we are doing it, and what specific things they can do to always help. This ensure that newer members can immediately be plugged in to existing activities, while long-time members can get a sense for what is working, and what is not. The plan is broken down into SMART goals (Specific, Measurable, Attainable, Realistic, and Timed) and these are broken down, as the national strategic plan is, into SWOT assessments (Strengths, Weaknesses, Opportunities, Threats). Under each goal there are also specific actionable items that will empower members to take concrete actions towards growing the party.

Goal #1

Organize new locals and expand current ones

By the end of this plan year, the GPVA should have at least 10 active locals with at least 5 dues-paying members in each local.

The GPVA consists of locals distributed throughout the state. Presently, there are 7 locals (New River Valley, Blue Ridge, Lynchburg, Shenandoah, Arlington, Fairfax, and Hampton Roads), but the number of members and degree of member involvement varies dramatically from local to local. Because locals are the primary means by which members are recruited and involvement maintained, it is critical that we have healthy, active locals across the state.

1. Reach out to every prospective member who registers on the website, providing them with a welcome pack to get involved. This should be automated if possible, and the local they would be a part of informed immediately (presently done by distribution through the LC listserv).

2. Creating local organizing efforts where no local exists. This includes more fully developing the local organizing handbook and placing it on the website for registered prospective members to use. This also includes sending someone from the state party to a new area after three people have registered to organize them into a local. This will require a "point-person" from the local organizing committee for an area with no affiliated locals (preferably near to where they live) who can help those members organize their first meeting and walk them through the process of forming the local.

3. Expanding membership within a local. This could include state party reimbursement for expenses incurred during tabling events, or other activities designed to raise awareness of the party and recruit members. Reimbursement process should ensure that state party funds are not squandered by requiring recipients to clarify the purpose of the funding request, limiting funds distributed (to ensure equitable access), and requiring follow-up to demonstrate use of the funds was successful in meeting GPVA

goals. Decisions regarding distribution of the funds should be made by the LC or those designated by the LC to make that decision.

Goal #2

Update the platform

Convene the platform committee and begin the process of sending platform changes to the LC for voting.

Select issues for each of the Four Pillars to focus on in the upcoming election year.

The Virginia Green Party platform is badly outdated referring to issues that are no longer relevant, using archaic terminology, and committing us publicly to positions that likely no longer reflect the actual preferences of the party. Last year, the GPVA adopted a new bylaw amendment to address this issue by re-empowering the platform committee and charging the General Secretary with convening it, until such time as a chair is elected. The system is in place to implement a new platform, steps just need to be taken to do it.

As we update the platform, we should also select four issues from it that correspond to each of the Four Pillars. These core issues will then be the focus of our advocacy work, and of whatever statewide candidates we run. Ensuring we have a focus message will also help with online and traditional media. As a recommendation, I'd propose implementing local-option Ranked-Choice Voting rules (Grassroots Democracy), Stopping the pipelines and other new fossil fuel infrastructure (Ecological Wisdom), implementing local-option laws for police reform (social justice). For our Peace/Non-Violence Pillar, we might think about demilitarizing Virginia's economy, gun control, or the threat of nuclear war.

Strengths

1. Platform bylaw change has already been passed.

2. The specific mechanism for suggesting new platform amendments already exists and is on our website. This includes examples, templates, and the actual submission form.

Weaknesses:

1. The present platform

2. Lack of membership willing to serve on the platform committee

Opportunities:

1. Recent political shifts will make our new platform quite popular.

Threats:

1. Delaying adoption of an updated platform will open the GPVA up to significant political risk to either defend positions the party no longer supports, or to contradict its written positions.

Goal #3

Compete in Local and Congressional 2022 elections

Have at least 5 different candidates running across the state, with at least 1 running for Congress

As we are a political party, the major focus of our organization is winning elections, and the 2022 elections pose a great way for us to connect with communities and advocate for Green policies and ideals. Although having 5 candidates, with at least 1 being a Congressional candidate, is not a huge number it does pose as another way to show that we are a serious body for political change and adds another platform for party growth to occur.

Strengths:

1. Fundraising from dues

2. Dedicated volunteers who have succeeded in achieving ballot access in previous election cycles

Weaknesses:

1. Few volunteers

- 2. Lack of obvious candidates willing and able to run effectively
- 3. Absence of locals across the state for GOTV efforts
- 4. Lack of membership willing to serve on the candidate exploration committee

Opportunities:

1. Voters turned away by the Democrats after the collapse of the Sanders campaign

2. Disaffected non-voters

Threats:

- 1. Sheep dogging efforts by the Democratic Party (e.g., Vote shaming)
- 2. Ballot Access threatened by Duopoly's attempts to keep third parties off the ballot

Goal #4

Budget

Pass an annual budget through the LC for the use of state funds

The recent passage of the Dues bylaw amendment by the LC ensures a stable source of revenue for the state party. Those funds can now be distributed in an agreed upon annual budget.

Strengths:

1. Dues ensure we have a stable source of income

Weaknesses:

1. We have no additional, consistent fundraising efforts

Opportunities:

1. n/a

Accomplishing the Goal

1. We may wish to spend some funds on reduced-cost legal counsel to ensure that fund distribution is handled ethically and in full compliance with state and federal law.

2. Estimate the number of dues-paying members.

3. Conduct additional fundraising efforts as needed in collaboration with Locals as needed.
